- PERMIT TERMS AND CONDITIONS**
1. Permit Fee, Collateral, System Development Fees, and Excess Capacity Fees must be paid prior to issuing the permit. NO REFUNDS SHALL BE MADE.
 2. All work must conform to the approved GESC Plans and the requirements of the GESC Manual, as amended, and other applicable codes and regulations.
 3. SEMSWA, or its designee, must be allowed unrestricted access to the site to conduct regular site inspections and/or perform corrective actions in the event the Permittee(s) fail to provide sufficient remedies to correct site deficiencies.
 4. It is the responsibilities of the Permittee(s) to review and be familiar with the GESC Program and its requirements, available online at www.semswa.org.
 5. If the property transfers ownership in part or in whole, the new owner shall be required to obtain a GESC Permit in accordance with the GESC Manual.
 6. If the Contractor is replaced by a different Contractor, the GESC Permit must be updated to reflect the change of responsibility.
 7. Earth disturbing activities shall not occur until the Permittee is in receipt of the executed GESC Permit.
 8. STOP WORK ORDERS: Any person who, without first having obtained a permit, has initiated earth disturbing activities and/or has failed to comply with the GESC Program shall be subject to a "Stop Work Order". Once issued all work shall be discontinued except for life safety-related items (e.g.: backfilling of holes and trenches) and corrective actions for compliance with the GESC Manual.
 9. This Permit must be active and cannot be allowed to expire until such time as the improvements associated with this permit have received Final Close-out from SEMSWA. Failure to do so may result in non-compliance fees.
 10. THIS PERMIT IS REVOCABLE. Failure to comply with these Terms and Conditions may result in the revocation of this permit, and a request for permit reissuance, including payment of Permit Fees.
