RESOLUTION 24-18

Authorization to Amend the Funding Agreement Regarding the Cherry Creek Drainage and Flood
Control Improvements at Arapahoe Road

WHEREAS, In Resolutions 21-18, 22-08, and 23-17 the Board authorized funding in the amount of \$170,000 and participation in an agreement with the Mile High Flood District (MHFD), Cherry Creek Basin Water Quality Authority (CCBWQA) and City of Aurora (City) for design and construction of the Cherry Creek at Arapahoe Road Drainage and Flood Control Improvements (Project); and

WHEREAS, SEMSWA, MHFD, CCBWQA, and the City are currently participating in a joint planning study titled "Cherry Creek Master Drainageway Plan" by Muller Engineering (Plan); and

WHEREAS, the instability of Cherry Creek at Arapahoe Road has resulted in severe erosion that puts existing infrastructures at risk; and

WHEREAS, Cherry Creek drainage and flood control improvements will address needed stream reclamation and, when practical, water quality enhancements within the upstream and downstream reaches of Cherry Creek at Arapahoe Road (the Project); and

WHEREAS, SEMSWA, MHFD, CCBWQA, and the City desire to combine resources to design and construct improvements for the Project as identified in the Plan; and

WHEREAS, \$200,000 is identified in SEMSWA's 2024 Capital Project Budget for the design and construction of the Project; and

WHEREAS, MHFD has agreed to manage the Project.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Board authorizes an increase in funding an amount not to exceed \$200,000 for the Project.
2. The Board authorizes the transfer of \$1,790.74 from Cherry Creek at Arapahoe Road; Project No. 100407 to this Project.
3. The Executive Director is authorized to execute an agreement with the MHFD, City of Aurora, and CCBWQA for the Project.
4. The SEMSWA funding for the Project is limited to \$371,790.74 without prior approval of the Board.
